1. Copy of your State Occupational license with current Utah address
2. Copy of your Malpractice Insurance Certificate
3. Copy of your DEA license with the current practice address
4. Updated W-9
5. Signed Release Form

If you did not receive a credentialing form, and you believe you should have, please contact your provider relations representative. We appreciate your help in serving our members and look forward to your continued participation in our dental networks.
